RESOLUTION NO. 20-03-234

REQUESTING THE DEPARTMENT OF HEALTH TO PROVIDE TESTING KITS, SURGICAL MASKS, ALCOHOLS AND THERMAL GUNS TO THE LOCAL GOVERNMENT OF BULALACAO, ORIENTAL MINDORO TO HELP PREVENT THE POSSIBLE PROLIFERATION OF NEW CORONAVIRUS IN THIS MUNICIPALITY.

“WHEREAS, pursuant to Section 16 of Republic Act 7160 otherwise known as the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted those necessarily implied therefrom, as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare, within their respective territorial jurisdictions, local government units shall ensure and support among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

“WHEREAS, in accordance to World Health Organization (WHO) definition, the Coronavirus (CoV) are large family of viruses that cause illness ranging from the common cold to more severe disease such as Middle East Respiratory Syndrome (MERS-CoV) and Severe Acute Respiratory Syndrome (SARS-CoV); the Coronavirus disease (COVID-19) is a new strain that was discovered in 2019 and has not been previously identified in humans; its common sign of infection include respiratory symptoms, fever, cough, shortness of breath and breathing difficulties; in more severe cases, infection can cause pneumonia, severe acute respiratory syndrome, kidney failure and even death;

"WHEREAS, on March 13, 2020 the Office of the Governor, Province of Oriental Mindoro issued an Executive Order No. 22 that restricting the movement of people and goods in order to prevent the entry and spread of COVID-19 that as per section 8 of this Executive Order there shall be a Community Quarantine for the whole province from 14 March 2020, at 12:01pm, until 25 March 2020 at 11:59pm;

"WHEREAS, the DOH-MIMAROPA reported on 3pm of March 15, 2020 that there are a total of 25 Persons Under Investigation (PUIs) and zero confirmed case of COVID-19 in the whole region of MIMAROPA;

"WHEREAS, the Municipality of Bulalacao, is a 3rd class municipality located at the southernmost tip of the Province of Oriental Mindoro that the threat of the new Coronavirus will be an arduous challenge for the residents and in order to fully prevent the possible spread of the Coronavirus within the municipality it will be a great help to have useful materials such as testing kits, surgical masks, alcohols and thermal guns, Now, therefore, be it;

RESOLVED AS IT IS HEREBY RESOLVED, To: Request the Department of Health to provide testing kits, surgical masks, alcohols and thermal guns to the Local Government Unit of Bulalacao, Oriental Mindoro to help prevent the possible proliferation of new Coronavirus in this Municipality.

RESOLVED FURTHER, To: Let copy of this resolution be furnished the Department of Health, Region IV-MIMAROPA for its information, appropriate action and kindest consideration.
