### **RESOLUTION NO. 18-04-096**

**RESOLUTION APPROVING SUPPLEMENTAL BUDGET NO. 1 CY 2018 OF BARANGAY POBLACION AMOUNTING TO SIXTY FIVE THOUSAND ONE HUNDRED THIRTY PESOS AND EIGHTY CENTAVOS (PhP65,130.80) TAKEN FROM 5% CALAMITY FUND 2012-2013 PASSED UNDER SANGGUNIANG BARANGAY APPROPRIATION ORDINANCE NO. 01-2018 DATED MARCH 12, 2018**

**RESOLVED AS IT IS HEREBY RESOLVED, To:** Approve Supplemental Budget No. 1 CY 2018 of Barangay Poblacion amounting to sixty five thousand one hundred thirty pesos and eighty centavos (PhP65,130.80) taken from 5% Calamity Fund 2012-2013 passed under Sangguniang Barangay Appropriation Ordinance No. 01-2018 dated March 12, 2018 with the following recommendations, to wit:

1. That, the procurement of supplies and materials is in accordance with RA 9184 (Government Procurement Reform Act);
2. That, the Sangguniang Barangay Poblacion, Bulalacao, Oriental Mindoro is likewise advise to strictly follow the usual accounting and auditing rules and regulations;
3. That, appropriations and disbursements from Barangay Disaster Risk Reduction and Management Fund shall be strictly in accordance with the purpose stated in the approved Barangay Disaster Risk Reduction and Management (BDRRM) Plan and in compliance with the provisions of RA 10121 or the Philippine Disaster Risk Reduction and Management Act of 2010.

4. That, compliance with all existing and applicable laws, rules and regulations shall be the sole responsibility of the Sangguniang Barangay of Poblacion in connection with the implementation of said appropriation ordinance.

**RESOLVED FURTHER**, that Sangguniang Barangay of Poblacion thru the Barangay Secretary and Municipal Accounting Office shall be furnished with a copy of the Resolution for their information and guidance.


