RESOLUTION NO. 19-03-049

RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 01-2018 OF BARANGAY BENLI ENTITLED "AN ORDINANCE APPROVING THE ANNUAL BUDGET IN THE AMOUNT OF FOUR MILLION ONE HUNDRED SEVENTY SEVEN THOUSAND FOUR HUNDRED FORTY THREE PESOS (PhP4,177,443.00) TAKEN FROM INTERNAL REVENUE ALLOTMENT (IRA) AND INCOME FROM GRANT AND DONATION OF BARANGAY BENLI, BULALACAO, ORIENTAL MINDORO" INOPERATIVE IN PART

"WHEREAS, Section 57 and Section 447 par (li) empower the Sangguniang Bayan to review all ordinances passed by the Sangguniang Barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and not to be inconsistent with law or municipal ordinance;

"WHEREAS, the Sangguniang Barangay of Benli, Bulalacao, Oriental Mindoro submitted its Annual Budget for FY 2019 showing therein the estimated sources of income and expenditures starting from January 1, 2019 up to December 31, 2019;

"WHEREAS, the Annual Budget for FY 2019 of Barangay Benli was duly taken up by the Sangguniang Bayan of Bulalacao, Oriental Mindoro in the regular session held on March 1, 2019 and was found to be consistent and in accordance with Annual Investment Program of Barangay Benli, with the advice that all projects funded under the 20% Development Fund be fully implemented and should not be realigned to any other projects unless completed or reprogrammed;

"WHEREAS, Sangguniang Barangay of Benli, Bulalacao, Oriental Mindoro is likewise advised to strictly follow the recommendations of the Local Finance Committee as reflected in the review letter attached herewith;

WHEREAS, it is therefore understood that disbursement of appropriation shall be guided by existing rules and regulations of Commission on Audit and all other government agencies, Now, therefore, be it ...

RESOLVED AS IT IS HEREBY RESOLVED, To: Declare the Appropriation Ordinance No. 01-2018 of Barangay Benli entitled "An ordinance approving the Annual Budget in the amount of four million one hundred seventy seven thousand four hundred forty three pesos (PhP4,177,443.00) taken from Internal Revenue Allotment (IRA) and Income from Grant and Donation of Barangay Benli, Bulalacao, Oriental Mindoro" **INOPERATIVE IN PART**, effective March 1,2019 subject to the posting requirements under Section 59 of R.A. No. 7160, and subject further to the following conditions:

1. Provide full appropriation for Year-end bonus and 5% Calamity Fund;
2. Provide sufficient appropriation for GAD Program, Protection of Children, Program for combating AIDS and enforcement of Comprehensive Dangerous Drugs Act; and
3. Break down lump sum appropriations to proper object of expenditures.
