### RESOLUTION NO. 18-08-224

**RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 02-2018, SUPPLEMENTAL BUDGET NO. 02-2018 OF BARANGAY POBLACION, BULALACAO, ORIENTAL MINDORO ENTITLED "APPROPRIATING THE AMOUNT OF FIFTEEN THOUSAND FOUR HUNDRED PESOS (PhP15,400.00) TAKEN FROM PERSONAL SERVICES AND UNAPPROPRIATED BALANCE TO AUGMENT FUND FOR CAPITAL OUTLAY PURCHASE OF AIRCONDITIONER" OPERATIVE IN ITS ENTIRETY**

**RESOLVED AS IT IS HEREBY RESOLVED To:** Declare Appropriation Ordinance No. 02-2018, Supplemental Budget No. 02-2018 of Barangay Poblacion, Bulalacao, Oriental Mindoro entitled "Appropriating the amount of fifteen thousand four hundred pesos (PhP15,400.00) taken from personal services and unappropriated balance to augment fund for capital outlay purchase of airconditioner" operative in its entirety, effective August 31,2018, subject to the posting requirements under Section 59 of R.A. No. 7160,






