RESOLUTION STRONGLY SUPPORTING THE LOCALIZED PEACE TALKS WITH THE COMMUNIST PARTY OF THE PHILIPPINES (CPP) THE NEW PEOPLE'S ARMY (NPA) AND THE NATIONAL DEMOCRATIC FRONT (NDF) AS AN ALTERNATIVE TO THE NATIONAL GOVERNMENT'S PEACE PROCESS

"WHEREAS, pursuant to Section 2, under Declaration of Policy of the Philippine Constitution, it is the policy of the State to prioritize the maintenance of peace and order, the protection of life, liberty and property and the promotion of the general welfare which are essential for the enjoyment by all the people of the blessings of democracy;

"WHEREAS, it is understood that the prime objective of the peace talks process is to address the roots of the armed conflict such as poverty, injustice and oppression among others and not to force the NPA to surrender;

"WHEREAS, the Municipality of Bulalacao, Province of Oriental Mindoro is a refuge to NPA forces as shown by several ambush and encounters with the military group which resulted to emotional trouble and disturbances, fear and worst is the lost of precious human lives;

"WHEREAS, in consideration of all this state of war and chaos, the Municipal Government of Bulalacao, Oriental Mindoro organized the Bulalacao Rebel Returnees Association and accredited it for membership in the Local Special Bodies enabling them the opportunity to take part in the identification and formulation of the Annual Investment Plan (AIP) to get financed for the implementation of programs and projects that shall provide them enough opportunities to engage themselves in an endeavor which more productive and beneficial to better achieve social and economic upliftment; Now,
