REQUESTING THE OFFICE OF THE PRESIDENTIAL ADVISER FOR THE PEACE PROCESS (OPAPP) TO FACILITATE THE ALLOCATION AND APPROPRIATION OF PHP50M EACH FOR THE CONSTRUCTION OF GATOL TO AGONG ROAD IN BARANGAY SAN ROQUE AND TAMBANGAN TO QUIPANGLAO TO SAN JUAN PROPER ROAD IN BARANGAY SAN JUAN, ALL OF THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO TO HELP COUNTER INSURGENCY BY STIMULATING ECONOMIC ACTIVITIES THRU GOOD ROAD NETWORK.
