RESOLUTION NO. 18-08-209

RESOLUTION STATING THE BASIS ON THE GRANT OF BIRTHDAY INCENTIVE TO OFFICIALS AND EMPLOYEES OF THE LOCAL GOVERNMENT UNIT OF BULALACAO, ORIENTAL MINDORO THEREBY EMPHASIZING THAT SUCH INCENTIVE SHOULD HAVE BEEN ALLOWED BY THE SANGGUNIANG PANLALAWIGAN OF ORIENTAL MINDORO

"WHEREAS, Section 447 (viii) of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that the Sangguniang Bayan shall determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or monthly from municipal funds and provide for expenditure necessary for the proper conduct of programs, projects, services and activities of the Municipal Government;

"WHEREAS, pursuant to the above cited law, the Sangguniang Bayan of Bulalacao, Oriental Mindoro enacted Special Ordinance No. 17-01-02 dated, January 27, 2017 to provide officials and employees with just, lawful and relevant imposition of benefit package;

"WHEREAS, the Local Government Unit of Bulalacao, Oriental Mindoro enacted Special Ordinance No. 17-01-02 and appropriates sufficient funds in the Municipal Annual Budget, CY 2018 to fully implement the program with an objective of maintaining high morale, and productive workforce that shall redound to the delivery of best basic social services to the people and community as a whole;


