RESOLUTION NO. 19-01-030

RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 18-12-19 OF BARANGAY BAGONG SIKAT ENTITLED "AN ORDINANCE APPROVING THE ANNUAL BUDGET IN THE AMOUNT OF ONE MILLION EIGHT HUNDRED FORTY FOUR THOUSAND SIX HUNDRED PESOS (PhP1,844,600.00) TAKEN FROM INTERNAL REVENUE ALLOTMENT (IRA), SHARE IN REAL PROPERTY TAX, COMMUNITY TAX, CLEARANCE AND CERTIFICATION FEES, INCOME FROM GRANT AND DONATION OF BARANGAY BAGONG SIKAT, BULALACAO, ORIENTAL MINDORO" INOPERATIVE IN PART

"WHEREAS, Section 57 and Section 447 par (li) empower the Sangguniang Bayan to review all ordinances passed by the Sangguniang Barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and not to be inconsistent with law or municipal ordinance;

"WHEREAS, the Sangguniang Barangay of Bagong Sikat, Bulalacao, Oriental Mindoro submitted its Annual Budget for FY 2019 showing therein the estimated sources of income and expenditures starting from January 1, 2019 up to December 31, 2019;

"WHEREAS, the Annual Budget for FY 2019 of Barangay Bagong Sikat was duly taken up by the Sangguniang Bayan of Bulalacao, Oriental Mindoro in the regular session held on January 25, 2019 and was found to be consistent and in accordance with Annual Investment Program of Barangay Bagong Sikat, with the advice that all projects funded under the 20% Development Fund be fully implemented and should not be realigned to any other projects unless completed or reprogrammed;

"WHEREAS, Sangguniang Barangay of Bagong Sikat, Bulalacao, Oriental Mindoro is likewise advised to strictly follow the recommendations of the Local Finance Committee as reflected in the review letter attached herewith;









"WHEREAS, it is therefore understood that disbursement of appropriation shall be guided by existing rules and regulations of Commission on Audit and all other government agencies, Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Declare the Appropriation Ordinance No. 18-12-19 of Barangay Bagong Sikat entitled "An ordinance approving the Annual Budget in the amount of one million eight hundred forty four thousand six hundred pesos (PhP1,844,600.00) taken from Internal Revenue Allotment (IRA), Share in Real Property Tax, Community Tax, Clearance and Certification Fees, Income from Grant and Donation of Barangay Bagong Sikat, Bulalacao, Oriental Mindoro" **INOPERATIVE IN PART**, effective January 25, 2019 subject to the posting requirements under Section 59 of R A No. 7160, and subject further to the following conditions:


1. Provide sufficient funds for PPAs for Gender and Development, combating AIDS, Senior Citizens and Persons with Disability;
2. Transfer the appropriation for the Honorarium of Sanitary Inspector to Personal Services and reduce the total PS to the allowable amount;
3. Provide full appropriation for Year-end bonus;
4. Lump sum appropriations should be broken down to proper object of expenditures;
5. Use proper account titles and account codes per COA NGAS Revised Chart of Accounts;




