RESOLUTION REQUESTING NATIONAL TASK FORCE TO END LOCAL COMMUNIST ARMED CONFLICT (NTF-ELCAC) TO ALLOCATE FUNDS FOR THE OPENING AND CONCRETING OF FARM-TO-MARKET ROADS FROM SITIOS ABINTANG TO BALDITAN-SUE-WARING-SILAD, CARUMATA-CABALWA-SILAD, LAGIT-WARING-PARAKASOY, BENLI PROPER-HALAWHAWAN-BALDITAN-LAGIT-WARING-PARAKASOY, AND FF CRUZ-HAMLOY-UMABANG ALL IN BARANGAY BENLI, MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, Executive Order No. 16, s. 2017 adopted the National Security Policy 2017-2022 which calls for the end of all armed threats in the Philippines and recognizes that interval social-political stability rests upon heading the rights that divide the nation by promoting participatory government, synergy of government development efforts and enhancing the participation and responsibilities of local government units (LGU's);
