**RESOLUTION EXTENDING THE PERIOD OF PENALTY IMPOSITION AND AUTHORIZING THE CONTINUOUS OPERATION OF BUSINESS ONE STOP SHOP (BOSS) FOR THREE (3) MONTHS STARTING FROM JANUARY 20, 2022 UP TO APRIL 20, 2022 FOR ALL BUSINESS APPLICANTS SECURING BUSINESS PERMITS IN THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO**

**"WHEREAS**, Section 167, Chapter 3 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that "Unless otherwise provided in this Code, all local taxes, fees and charges shall be paid within the first twenty (20) days of January or of each subsequent quarter, as the case may be. The Sanggunian concerned, may for a justifiable reason or cause, extend the time for payment of each taxes, fees or charges without surcharges or penalties but only for a period not exceeding six (6) months;

**"WHEREAS**, the Local Government Unit of Bulalacao believes that the business sector is a valuable partner in the pursuit of economic development that it continue to adopt the best strategy to provide convenience to all business applicants through the establishment of a Business One Stop Shop (BOSS) where all concerned offices are gathered in one area;

**"WHEREAS**, in support to financial recovery from the adverse effect brought by pandemic, all business applications can be processed without penalties or surcharges until April 20, 2022; **Now, therefore, be it**

**RESOLVED AS IT IS HEREBY RESOLVED To:** Extend the period of penalty imposition and authorizing the continuous operation of Business One Stop Shop (BOSS) for three (3) months starting from January 20, 2022 up to April 20, 2022 for all business applicants securing business permits in the Municipality of Bulalacao, Oriental Mindoro;


