HIGHWAYS TO CONSTRUCT WATER IMPOUNDING DAMS IN UPPER  
PARTS OF BARANGAYS NASUCOB, CAMBUNANG AND BENLI TO  
PREVENT FLASH FLOODS IN LOWER PARTS OF THE MUNICIPALITY OF

**"WHEREAS**, Section 16 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare, within their respective territorial jurisdictions, local government units shall promote health and safety;

**"WHEREAS**, Bulalacao is well-nigh to being an agro-eco-tourism destination of the Province of Oriental Mindoro, it has a municipal government that aims to establish an efficient local organization which is responsive to the needs of the locality and effectively manages its resources to sustain growth and development;

**"WHEREAS**, Bulalacao being one of the agricultural municipality in the said province is lacking of water impounding dam that can hold back water and develop reservoir by holding as much water as possible during the rainy season which can be used for immediate or future use;

“WHEREAS, the provision of water impounding dam would be beneficial to the locals especially the farmers of Bulalacao, it would help in soil and water conservation and flood control that could provide supplemental irrigation water for intensified crop production which would result to substantial increase in farmer’s income, it could also support in the generation of power of certain barangays;

“WHEREAS, the Local Government of Bulalacao is aiming to have water impounding dams to three of its vast land area barangays which are Nasucob, Cambunang and Benli, thus, it needs support from higher government agencies for its complete construction; Now, therefore, be it...






