SALAS REGARDING THE RENTAL OF A WATER SPRING SITUATED IN SITIO TULALE, BARANGAY MAUJAO OWNED BY THE LATTER WHICH SHALL SERVE AS THE SOURCE OF POTABLE WATER FOR BARANGAYS POBLACION AND CAMPAASAN IN CONSIDERATION OF A MONTHLY RENTAL FEE OF SIX THOUSAND PESOS (PhP6,000.00) STARTING JULY 1, 2022 UP TO JUNE 30, 2023


RESOLVED FURTHER, That: Any change or alteration in the Kasunduan originally presented shall have no effect and therefore null and void;
