**“WHEREAS**, Section 16 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare, within their respective territorial jurisdictions;

**“WHEREAS**, Bulalacao, a 3<sup>rd</sup> class municipality is a vast agricultural land, has 15 barangays where some are home to indigenous people called Hanunuo-Mangyans, has a total agricultural land area of 10,325.80 hectares where 6,016 individuals are employed in the agricultural sector;

**“WHEREAS**, coconut industry is one of the means of income of the people of Bulalacao and it helps in boosting the municipal economy, however, there is no definite place or a satellite nursery that could cater production of coconut seedling;


**"WHEREAS**, Bulalacao has an Agricultural Center/Breeding Station located at one of its top producing agricultural barangay which is the Barangay Nasucob, it is ideal to construct a coconut satellite nursery in the said center that would help the coconut farmers to gain production and profitability which will not only contribute to the stability of coconut supply in the municipal market but would also support the trading and transport of products to other municipality and/or provinces; Now, therefore, be it...






