"WHEREAS, the Sangguniang Barangay of Campaasan, Bulalacao, Oriental Mindoro is likewise advised to strictly follow the recommendations of the Local Finance Committee as reflected in the attached review letter of the Local Finance Committee which became an integral part of this resolution;
