RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 001 SERIES OF 2022, FY 2023 ANNUAL BUDGET OF BARANGAY BENLI, BULALACAO, ORIENTAL MINDORO APPROPRIATING THE AMOUNT OF SIX MILLION EIGHT HUNDRED FIFTEEN THOUSAND TWO HUNDRED EIGHTY-SIX PESOS (PHP 6,815,286.00) OPERATIVE IN ITS ENTIRETY

"WHEREAS, the Annual Budget for FY 2023 of Barangay Benli was duly taken by the Sangguniang Bayan of Bulalacao, Oriental Mindoro in the Regular Session on June 13, 2023 and was found to be consistent with pertinent laws, rules and regulations;

"WHEREAS, the Sangguniang Barangay of Benli, Bulalacao, Oriental Mindoro is likewise advised to strictly follow the recommendations of the Local Finance Committee as reflected in the attached review letter of the Local Finance Committee which became an integral part of this resolution;


