**RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 2022-01, FY 2023 ANNUAL BUDGET OF BARANGAY SAN ISIDRO, BULALACAO, ORIENTAL MINDORO APPROPRIATING THE AMOUNT OF TWO MILLION ONE HUNDRED NINETY-SIX THOUSAND FIVE HUNDRED THIRTY-SEVEN PESOS AND EIGHTY-ONE CENTAVOS (PHP 2,196,537.81) OPERATIVE IN ITS ENTIRETY**
