

ORDINANCE NO. 066

1994

IMPOSING PRICE CONTROL ON MEAT, FISH, CRAB AND SHRIMP SOLD TO THE PUBLIC IN THE MUNICIPALITY OF BULALACAO, OR. MINDORO

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. There shall be imposed a price control on meat, fish, crab and shrimp sold to the public in the Municipality of Bulalacao, Oriental Mindoro, by providing a ceiling price on which these goods can be sold as follows:


SECTION 2. Any person found violating this ordinance shall be punished by a fine of not less than Three Hundred Pesos (₱300.00) but shall not exceed Two Thousand and Five Hundred Pesos (₱ 2,500.00) or by an imprisonment of not less than one (1) month but not to exceed six (6) months or both such fine and imprisonment at the discretion of the Court;

SECTION 3. Ordinance inconsistent hereof are hereby repealed, modified accordingly;

SECTION 4. This ordinance shall take effect ten (10) days after its posting.
