

AN ORDINANCE DIRECTING THE BUYERS TO BUY ONLY FROM BID AWARDEES WHO WERE GRANTED EXCLUSIVE PRIVILEGE TO CATCH LAPU LAPU FRY, " BANGUS" FRY OR KAWAG KAWAG FRY OF OTHER SPECIES OF FISH PROPAGATION WITHIN THE MUNICIPAL WATERS OF BULALACAO, ORIENTAL MINDORO

WHEREAS, Article F. Section 5F, 04 of the New Tax Ordinance of Bulalacao, Oriental Mindoro provides for the Zonification of Municipal Waters of this Municipality;

WHEREAS, there are determined six (6) Municipal waters Zones, namely:

- Zone 1. From Culasi point to Buyayao point
(4-5 kilometers distance)
Government reservation
- Zone 2. From Buyayao point to Maasin point
(20 kilometer distance)
- Zone 3. From Maasin point to Caratao point
(20 kilometer distance)
- Zone 4. From Caratao point to Tambi-Tambi point
(6 kilometer distance)
- Zone 5. From Tambi-Tambi point to Mangusing point
(3kilometer distance)
- Zone 6. From Mangusing point to Burungcaan point
(15 kilometer distance)

WHEREAS, one of the purposes for the Zonification of Municipal waters was the awarding, through public bidding, areas for the gathering of fry;

WHEREAS, the catching of Lapu Lapu fry, Bangus fry or Kawag-Kawag fry of other species for propagation shall be considered as exclusive fishery privileges which shall be granted to the highest bidder in Public bidding;

WHEREAS, the Municipal Government must protect the rights and interest of the bid awardees;

NOW THEREFORE:

BE, it enacted by the Sangguniang Bayan of Bulalacao, Oriental Mindoro in session assembled;

SECTION 1. All buyers of Lapu Lapu fry, Bangus fry or Kawag Kawag or fry of other species of fish propagation must buy only from the legitimate bid awardees who are granted exclusive privilege to catch the same;

SECTION 2. PENALTY. Any violation of the provisions of this Ordinance shall be punished by a fine of not less than One Thousand Pesos (P1,000.00) but not more than Two Thousand and Five Hundred Pesos (P2,500.00) or imprisonment of not less than one (1) month but not more than six (6) months, or both such fine and imprisonment at the discretion of the Court;


SECTION 3. REPEELING CLAUSE. All Ordinances inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly;

SECTION 4. EFFECTIVITY. This Ordinance shall take effect immediately after its passage;

RESOLVED FURTHER, that copies of this Ordinance be furnished the Municipal Treasurer and Philippine National Police, Bulalacao, Oriental Mindoro for their information and proper action.
