SPECIAL ORDINANCE NO. 09-04-12

SPECIAL ORDINANCE CREATING THE MUNICIPAL SCHOLARSHIP COMMITTEE FOR THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO, EFFECTIVE SY 2009 AND EVERY SCHOOL YEAR THEREAFTER

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. CREATION/POLICY: In order to ensure effective implementation of scholarship grants to the qualified, poor and deserving students for their free tertiary education, the Municipal Scholarship Committee for the Municipality of Bulalacao, Province of Oriental Mindoro is hereby created;

SEC. 2. COMPOSITION. The herein created Municipal Scholarship Committee shall be composed of the Municipal Mayor as Chairman and the following as Members:

- i. Chairman, SB Committee on Education;
- ii. Principal, Bulalacao National High School;
- iii. Municipal Social Welfare and Development Officer;
- iv. Municipal Planning and Development Officer;
- v. Municipal Budget Officer;
- vi. President, Liga ng mga Barangay;
- vii. President, Sangguniang Kabataan Federation;




SEC. 3. POWERS, FUNCTIONS AND DUTIES: The Municipal Scholarship Committee shall have the following powers, functions and duties:


- i. Administer the implementation of the Scholarship Program of the Municipality;
- ii. Appropriate and disburse the necessary funds for the purpose in the amount of Php10,000.00 per semester for each and every grantee/scholar;
- iii. Undertake investigation on any valid charge/charges or complaint against the grantee/scholar;
- iv. Conduct periodic monitoring and evaluation on the academic performance of the grantee/scholar; and implementation of the Program;
- v. Maintain and keep records of the Program.


SEC. 4. This Special Ordinance shall take effect in SY 2009 and every year thereafter.


