The session was called to order at 9:30 o'clock in the morning.

The calling of the roll was performed with the members answering present when their respective names were called.

The minutes of the previous session was also read and there no objection so on motion of Honorable Modesto O. Bacawag, seconded by Hon. Ulpiano C. Pandino, the minutes stands as confirmed.

Hon. Ulpiano C. Pandino broughtout the vacancy of one membership in the office of the Sangguniang Bayan which according to him shall be filled-up.

In this connection the Presiding Officer said the appointment of one member in the Office of the Sangguniang Bayan be set aside for further study at the next session... UNANIMOUSLY APPROVED.

Hon. Modesto O. Bacawag likewise broughtout the frequent absences in office of the Municipal Treasurer. He said business transactions which the office of the Municipal is much concern could not be acted in due time.

The session was suspended at 10:00 AM to entertain the barangay Captains of this Municipality. Barangay Captain Lucrario Maximo of Belatesan in his short deliberation supported by Barangay Captain Tiburcio Bayo said their actuation is miserable because since their assumption in office in 1980 their barangay budget has not been prepared, hence delayed the withdrawal of money for their barangay projects.

Mayor Bago assured the barangay Captains to hire someone to help them prepare their barangay budget.. UNANIMOUSLY APPROVED.

The barangay Captains have agreed to attend the Inauguration of the New Municipal building which was scheduled this coming January 4. Provincial and Town Officials in the province are coming to attend the inauguration. Mayor Bago said.

The session was resumed at 11:00 on motion of Hon. Ulpiano C. Pandino, duly seconded by this Honorable body to take-up matters concerning the appropriation of the sum of ₱5,000.00 for expenses of the Inauguration of the new Municipal building.

APPROPRIATING THE SUM OF P 5,000.00 TO BE TAKEN FROM ANY AVAILABLE FUND OR TO REVERT ANY FUND ALREADY APPROPRIATED BUT NEVERTHELESS NOT YET UTILIZE FOR THE PURPOSE FOR EXPENSES OF THE INAUGURATION OF THE NEW MUNICIPAL BUILDING ON JANUARY 4, 1984

SECTION 1. There is hereby appropriated the sum of FIVE THOUSAND PESOS (P5,000.00) TO BE TAKEN FROM ANY AVAILABLE FUND OR TO REVERT ANY FUND ALREADY APPROPRIATED BUT NEVERTHELESS NOT YET UTILIZE FOR THE PURPOSE FOR EXPENSES OF THE INAUGURATION OF THE NEW MUNICIPAL BUILDING ON JANUARY 4, 1984

SECTION 2. This Ordinance shall take effect immediately after its passage;
