The meeting was called to order at 9:30 O'clock in the morning by the Presiding Officer.

The calling of the roll was performed by the Recorder with the members answering present when their respective names were called.

The minutes of the previous meeting was also read by the Recorder and there no objection so on motion of Hon. Modesto O. Bacawag, seconded by Hon. Amparo S. Gregorio, the minutes stands as confirmed.

The letters from the station Commander of this town, the Provincial Assessor at Calapan, Assemblyman Frisco F. San Juan, Batasang Pambansa, the Municipal Mayor of Pola, Oriental Mindoro and the President of the KRBP, Quezon City were read to this body for comment.

The letters of the Station Commander and the letter of the KRBP Resident which is requesting for appropriation of P500.00 each was referred to the Municipal Treasurer by the Presiding Officer himself for comment. The Municipal Treasurer said, there is fund available for the purpose, so on motion of Hon. Ulpiano C. Pandino, seconded by Hon. Perpetuo C. Santos, an Appropriation Ordinance Appropriating the amount of P1,000.00 is hereby enacted and approved.

Likewise, Hon. Modesto O. Bacawag moved and Unanimously seconded by this body that the letters of the station commander must be referred to the Regional Office Bureau of Fisheries and Aquatic Resources, Manila, copy furnished, the Officer-in-charge, Bureau of Fisheries and Aquatic Resources, Calapan, Oriental Mindoro for comment or support.

The damages of the Cabilian Irrigation Project caused by Typhoon Ilang and Daling was reported by Hon. Ulpiano C. Pandino to this body with his request that a Resolution requesting Engineer Bienvenido Unali, Chief Provincial Irrigation Office, NIA, Calapan, Oriental Mindoro must be enacted. At this juncture, Hon. Modesto O. Bacawag moved and seconded by Hon. Perpetuo C. Santos the enactment of said Resolution.

PFC Nathaniel Gonzales of the INF Station of this Town and the Coast Guard Detachment were invited to attend the meeting relative to the implementation of Municipal Ordinances.

A copy of the Tax Ordinance was given to the Coast guard detachment for his reference. While PFC Nathaniel Gonzales was asked by Hon. Wilfredo F. Babilo about the report that they had apprehended illegal fishermen through the explosive of dynamite. Gonzales has confirmed the report by showing to this Honorable Body the complaint against the illegal fishermen. Gonzales further said that one motor banca, one diving materials, called "Cepandra" and fish were confiscated for exhibits. And that the fishermen were temporarily released due to the delay of filing the complaint to the Fiscals Office at Pinamalayan, Oriental Mindoro. However, the names of the accused in this particular case were not mentioned by Gonzales.

SUPPLEMENTAL BUDGET NO. 7
FOR CALENDAR YEAR 1981

APPROPRIATING THE AMOUNT OF ONE THOUSAND (P1,000.00) PESOS FROM ANY AVAILABLE FUND, P500.00 of which is for the PURCHASE OF GASOLINE FOR SEABORNE PATROL OF PC-INF OF THIS TOWN AND ANOTHER P500.00 AS CONTRIBUTION TO THE PAMBANSANG KATIPUNAN NG MGA PUNONG BAYAN NG PILIPINAS (PKPBP) PROJECTS, AS PER MEMORANDUM CIRCULAR NO. 80-74, DATED DECEMBER 23, 1980, OF THE MINISTRY OF LOCAL GOVERNMENT AND COMMUNITY DEVELOPMENT, QUEZON CITY.

Section I.- There is hereby Appropriated the sum of ONE THOUSAND (P1,000.00) PESOS from any available fund, P500.00 of which is for the purchase of gasoline for seaborne patrol of the PC-INF of this town and another P500.00 as contribution to the PAMBANSANG KATIPUNAN NG MGA PUNONG BAYAN NG PILIPINAS (PKPBP) Projects as per Memorandum Circular No. 80-74, dated December 23, 1980, of the Ministry of Local Government and Community Development, Quezon City;

Section 2. This Ordinance shall take effect immediately upon its approval.
