RESOLUTION NO. 14

FIXING THE DATE OF THE REGULAR AND SPECIAL SESSIONS OF THE SANGGUNIANG BAYAN OF BULALACAO, ORIENTAL MINDORO IN ACCORDANCE WITH MEMORANDUM CIRCULAR NO. 80-18 S. OF 1980.

WHEREAS, this Honorable Body, the Sangguniang Bayan of Bulalacao, Oriental Mindoro previously held twelve (12) Regular and 6 Special sessions every year;

WHEREAS, Memorandum Circular No. 80-18 s. of 1980 issued by the Ministry of Local Government and Community Development hereby authorized all Sangguniang Bayan to hold two regular sessions every month and one Special session as maybe called by the Mayor. Provided, however, that if a special session will be called by the Mayor, the last Regular Session shall not be held anymore;


WHEREAS, the two regular sessions set by the Sangguniang Bayan shall be held on the first and last Monday of every month thereof;

NOW, THEREFORE, resolved as it is hereby resolved to hold 2 regular sessions every month, one of which is to be held on the first Monday and the other, on the last Monday of every month. Provided, however, that if a special session will be called by the Mayor, the last regular session shall not be held anymore. Provided, further, that the Regular and Special sessions shall not exceed 24 sessions every year.

RESOLVED, FURTHER, that copy of this Resolution be furnished the Municipal Treasurer, Bulalacao, Oriental Mindoro for his information and guidance.
