RESOLVED, to approve the following Appropriation Ordinance:

MUNICIPAL APPROPRIATION ORDINANCE NO. I  
FOR CALENDAR YEAR 1985

APPROPRIATING THE SUM OF ₱460,168.12 FROM THE GENERAL FUND AND ₱249,919.32 FROM THE INFRASTRUCTURE FUND FOR VARIOUS OPERATING EXPENSES OF THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO

SECTION 1. This Ordinance shall be known as the Municipal Budget of the Municipality of Bulalacao, Oriental Mindoro for Calendar year 1985;

SECTION 2. The amount of ₱460,168.12 and ₱249,919.32 herein appropriated shall be taken from the General and Infrastructure funds, respectively for various operating expenses of the municipality of Bulalacao, Oriental Mindoro, for Calendar year 1985;

SECTION 3. All expenses chargeable against the appropriation herein mentioned shall be made upon properly executed Voucher duly approved by the Municipal Mayor and the Municipal Treasurer in accordance with the existing rules, laws and regulations;

SECTION 4. This Ordinance shall take effect immediately;

RESOLVED, FURTHER, that this Appropriation Ordinance be forwarded to the Provincial Treasurer and the Provincial Budget Officer, Calapan, Oriental Mindoro for review and approval;
