WHEREAS, the Secondary Education should be made a strong link in the Phi-
lippine Educational System;

WHEREAS, the funding of essential expenses, and as standard salaries of
High School Teachers and personnel, creation of new positions and improvements,
constructions, maintenance and repair of school plant has been a perennial prob-
lem of the local government;

WHEREAS, this municipality had sent to the former Secretary of Education
and Culture Resolution No. 14 series of 1977 recommending the conversion of
Bulalacao Municipal High School into Bulalacao National High School;


WHEREAS, this body was informed that four (4) Municipal High School in
Occidental Mindoro were already converted into National High Schools;


NOW THEREFORE, rendered as it is hereby resolved that the Sangguniang

High School;


RESOLVED, FURTHER, that copies of this Resolution be furnished his Excel-

the above resolution is UNANIMOUSLY APPROVED:


There having no other business to be transacted so on motion of Hon. Wil-






