ORDINANCE 1

ORDINANCE NO. 5 ✓

AMENDING SUB-PARAGRAPH E OF ORDINANCE NO. 3, SERIES OF 1983 BY CHANGING THE MEASUREMENT OF PER SQUARE METAR TO LINEAR MEASURE AND SHALL PROVIDE FINES AND PUNISHMENT FOR VIOLATION HEREOF

SECTION I.- All persons having Commercial dry goods, stores, eateries, rollatas and etc., have hereby required to pay to the Municipal Treasurer or his authorized representatives the corresponding amount enumerated hereunder before occupying certain place or space in the public streets, roads and lanes, during the town fiesta of Bulalacao, Oriental Mindoro;

a) Application Fee	₱10.00
b) Mayor's Permit fee	15.00
c) Medical & Sanitary fee	5.00
d) Service fee	5.00
e) Rental fee, Per linear meter.	25.00

SECTION 2.- No person or persons are allowed to occupy any place or space without paying the corresponding fees enumerated in Section I, hereof;


SECTION 3.- Violation of this Ordinance or parts thereof, shall be fined the amount of Twenty Five (P25.00) to Two Hundred (P200.00) Pesos or an imprisonment of Ten (10) to Thirty (30) days or both such fine and imprisonment at the discretion of the court;


SECTION 4.- Ordinance or Ordinances in consistent with the provisions of this Ordinance are hereby repealed or modified accordingly;

SECTION 5.- This Ordinance shall take effect immediately after its passage;


UNANIMOUSLY APPROVED






