AUTHORIZING HON. GUILLERMO H. SALAS, OIC MUNICIPAL MAYOR, TO SIGN A DEED OF SALE OF ONE HECTARE OF LAND, REPRESENTING THE MUNICIPALITY OF BULALAGAO WITH THE GENERAL MANAGER, REPRESENTING ONMECO II, PINAMALAYAN, THIS PROVINCE

WHEREAS, the members of the Sangguniang Bayan in their regular session held on July 2, had agreed to sell one hectare out of less than three (3) hectares of title land owned by the Municipal government in Sitio Maradatum to ORMECO II to effectuate the immediate installation of electricity in this town;

WHEREAS, execution of a Deed of Sale of the above-mentioned property by and between the Municipal government and ORMECO II, is of vital importance;

NOW, THEREFORE, resolved, as it is hereby resolved to authorize Hon. Guillermo H. Salas to sign a Deed of Sale of One hectare of land, representing the Municipal government with the General Manager, representing ORMECO II;
