REQUESTING THE PROVINCIAL COMMANDER, PC HEADQUARTERS, CALAPAN, ORIENTAL MINDORO TO CONSIDER THE APPLICATION OF INP APPLICANTS IN THE MUNICIPALITY OF BULALACAO

WHEREAS, the municipality of Bulalacao, Oriental Mindoro has a population of 21,000 and fifteen (15) more Policemen are needed in order to meet the proportionate ratio of one Policeman for every one thousand inhabitants as provided for in the Police Act of 1966;

WHEREAS, considering the peace and order situation of this municipality, appointment of fifteen Policeman is of vital importance;

WHEREAS, there are no Civil service eligible Police applicants in this municipality;

WHEREAS, there are already young people in this municipality who had applied to the Integrated National Police;

WHEREAS, people of this town preferred that applicants to the Integrated National police must be a bonafide residents of this municipality because they know the in and out of all places and geographical areas here;

NOW, THEREFORE, resolved as it is hereby resolved to request the Provincial Commander, Calapan, Oriental Mindoro to consider the application of the residents of this municipality to the Police service;
