The session was called to order at 9:30 o'clock in the morning.

The calling of the roll was performed by the Secretary with the members answering present when their respective names were called.

The minutes of the previous session was also read by the Secretary and there no objection so on motion of Hon. Perpetuo C. Cantos, seconded by Hon. Edilberto M. Pajila, the minutes stands as confirmed.

Municipal Treasurer Wilfredo V. de Leon was invited to attend the session in order to explain in detail regarding the outstanding obligation for CY 1985 which appeared in the proposed Supplemental Budget for CY 1986. Treasurer de Leon said if ever this outstanding obligation has not been paid by the previous Municipal Treasurers, this will be carried on the next fiscal year and will appear in the budget as outstanding obligation.

At this juncture, the amount of ₱81,997.50 which derived from the surplus of Infrastructure fund is appropriated for the cementing and maintenance of Municipal streets, while the amount of ₱77,653.95 was reserved for the terminal pay of Municipal employees in case of sudden change of the administration.

MUNICIPAL APPROPRIATION ORDINANCE, APPROPRIATING THE SUM OF ₱81,997.50 AND ₱77,653.95 TO BE TAKEN FROM THE SURPLUS OF INFRASTRUCTURE AND GENERAL FUNDS for cy 1985.

SECTION 1. This Ordinance shall be known as Municipal Appropriation Ordinance No. 2, Supplemental Budget No. I of the municipality of Bulalacao, Oriental Mindoro for CY 1986;

SECTION 2. The sum of ₱81,997.50 herein appropriated shall be taken from the surplus of Infrastructure funds and ₱77,653.95 from the surplus of General funds for the cementing and maintenance of Municipal streets and for the terminal pay of Municipal employees, respectively;
