RESOLUTION REQUESTING HER EXCELLENCY PRESIDENT CORAZON C. AQUINO, MALACANANG,
MANILA TO RETAIN THE OPERATION OF COAL MINE IN THE BARANGAY OF CAMBUNANG, BULA-
LACAO, ORIENTAL MINDORO

WHEREAS, on June 21, 1986 the Minorities (Hanunuo) throughout the
Province of Oriental Mindoro, particularly from the town of Baco, San Teodoro,
Bongabon, Roxas, Mansalay and Bulalacao, stage a big rally at the Camp of FF
Cruz & Mining Co., a legitimate Coal Mine now operating in the Barangay of Cam-
bunang, this municipality;

WHEREAS, the main objective of the rally is to stop the operation of
said Coal Mine;

WHEREAS, the people of Barangay Cambunang, through the Sangguniang
Barangay strongly opposed or object to the rally of the Minorities on the fol-
lowing grounds to wit: a) That if the operation of the Coal Mine will be stopped,
One thousand (1,000) inhabitants more or less living in this barangay will surely
starve; b) That criminality will increase and this will be a problem on the part
of the government; c) That this will affect the Economy of the country because
Coal serves as fuel; d) That the hope of the little town of Bulalacao for a be-
tter and a prosperous municipality will not be achieved; e) that not only Chris-
tians who will be effected and lost job, but also the minorities as well;

WHEREAS, no land of the Minorities in the area of Coal mine operation
in this barangay was affected, but due to manipulation of the Peace Corp who
wants to grab the opportunity of expanding the Hanunuo Pundasyon, hence the ral-
ly was done;

WHEREAS, Problem of employment in this municipality will increase if
the FF Cruz & Mining Co. will be stopped of its operation;

NOW, THEREFORE, on motion of Kagawad Ulpiano Paigao, and duly secon-
ded by Kagawad Teodoro Farol be it;

RESOLVED, as it is hereby resolved, to request Her Excellency Presi-
dent Corazon C. Aquino, Malacanang, Manila to retain the operation of the Coal
Mins in the Barangay of Cambunang, this Municipality subject of the rally of
Minorities, held on June 21, 1986;

RESOLVED, FURTHER, that copies of this resolution be furnished Her
Excellency President Corazon C. Aquino, Malacanang Manila for her information,
and appropriate action;
