" RESOLUTION NO. 93-11-72

COMPLAINING THE HABITUAL ABSENTEEISM AND GROSS NEGLIGENCE OR DERELICTION OF DUTY OF COUNCILOR ELMO M. BACULINAO, MEMBER OF THE SANGGUNIANG BAYAN OF BULALACAO, ORIENTAL MINDORO, TO THE SANGGUNIANG PANLALAWIGAN OF THE PROVINCE OF ORIENTAL MINDORO

"WHEREAS, it is enshrined in the Constitution of the Republic of the Philippines that public office is a public trust and that public officers and employees must at all times be accountable to the people, serve them with utmost responsibility, integrity, loyalty, and efficiency, act with patriotism and justice, and lead modest lives;

"WHEREAS, the abovequoted provision of the fundamental law of the land, in this body's closer assessment, is betrayed by Councilor Elmo M. Baculinao's constant and habitual absenteeism resulting to the delay if not total inaction to the proposed measures referred to the committees of which he is the chairman, vice chairman or a member; namely:

Chairman:

- Committee on Cooperatives
- Committee on Trade, Commerce and Industry

(Former Chairman, from July 1992 - May 1993)

- Committee on Agriculture

Vice Chairman:

- Committee on Rules and Privileges
- Committee on Peace and Order and Public Safety
- Committee on Public works

Member:

- Committee on Public Utilities and Facilities
- Committee on Market and Slaughterhouse

"WHEREAS, Councilor Baculinao posted a measly fifty-one percent (51%) attendance, being present only thirty three (33) times out of the seventy-six regular and special sessions held from July 1992 to November 22, 1993 as shown in the attached certification by the personnel officer of this municipality;

"WHEREAS, the members of this body did not fail in reminding Councilor Baculinao of his erring behaviour as evidenced by the herein attached copy of letter to the said councilor dated January 11, 1993;

"WHEREAS, this disappointing behaviour of Councilor Elmo M. Baculinao makes a mockery of the law, of his colleagues in the Sangguniang Bayan and especially, of the trust given to him by the constituents who expect better service and performance from their leaders;

"WHEREAS, among the grounds for disciplinary actions against any erring elective officials as spelled out in Section 60 par (c) of Republic Act 7160 otherwise known as Local Government Code of 1991 are dishonesty, misconduct in office, gross negligence, or dereliction of duty;

"WHEREAS, Section 61 par (b) of the same law provides that a complaint against any elective official of a municipality shall be filed before the Sangguniang Panlalawigan;

NOW THEREFORE: RESOLVED AS IT IS HEREBY RESOLVED to complain the habitual absenteeism and gross negligence or dereliction of duty of Councilor Elmo M. Baculinao, member of this Sangguniang Bayan, to the Sangguniang Panlalawigan of the Province of Oriental Mindoro;


