" RESOLUTION NO. 93-06-047

RESOLUTION REQUESTING THE PROVINCIAL HEALTH OFFICER TO IMMEDIATELY RELEASE THE MOOE AUGMENTATION FUND FOR THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO

"WHEREAS, it is learned that the MOOE Augmentation Fund for the Municipality of Bulalacao-a Low Income Municipality under the Pro-Poor Program, had been mailed to the Oriental Mindoro Provincial Health Office on November 13, 1992 through Check Number 002773 dated November 6, 1992;

"WHEREAS, as per instructions of Director Teresita M. Bonoan, Community Health Service, Department Of Health, said augmentation fund can be used for any purposes that will help the field health staff in delivering the basic health services faster, efficient and more effective; that the head of unit in consultation with his staff, will be the one to determine the commodities or activities for which the said fund should be used;

"WHEREAS, the amount of eighteen thousand pesos (P18,000.00), as Bulalacao is provided with an additional budget of two thousand pesos (P2,000.00) effective April 1 to December 31, 1992, has not yet been released for unknown reasons;

"WHEREAS, it is only but proper that the Provincial Health Office release whatever financial or material assistance due to the poor Municipality of Bulalacao, Oriental Mindoro upon the latter's completion with all the necessary requirements;

NOW THEREFORE:

BE IT RESOLVED as it is HEREBY RESOLVED to request the Provincial Health Office to release immediately the MOOE Augmentation Fund for Bulalacao, Oriental Mindoro amounting to (P18,000.00);

RESOLVED FURTHER, that copies of this Resolution be furnished Provincial Health Officer, Calapan, Oriental Mindoro and Director Teresita M. Bonoan, Community Health Service, Department of Health, Manila, for their information and appropriate action.
