ORDINANCE NO. 93-09-056

DESIGNATING THE FRONT OF THE OLD PUBLIC MARKET BUILDING AS PARKING AREA FOR TRICYCLES AND IMPOSING PARKING FEE THEREFOR

Sponsored by: Hon. Rey T. Amparo

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. The front of the Old Public Market Building is hereby designated as parking area for all tricycles at this Municipality.

SECTION 2. No driver shall park a tricycle or permit to stand, whether attended or unattended upon any place except at the place herein designated as parking area.

SECTION 3. There shall be collected a daily parking fee of Five Pesos (P5.00) from tricycle drivers for the use of municipal owned parking area.

SECTION 4. The fee imposed herein shall be paid to the Municipal Treasurer or to his authorized representative upon parking thereon.


SECTION 5. Any violation of this Ordinance shall be punished by a fine of not less than Three Hundred Pesos (P300.00) but not more than Two Thousand and Five Hundred Pesos (P2,500.00) or imprisonment of not less than one (1) month but not more than six (6) months or both such fine and imprisonment at the discretion of the Court.


SECTION 6. Ordinances inconsistent hereof are hereby repealed, modified accordingly.




SECTION 7. This Ordinance shall take effect ten (10) days after its posting.


