ORDINANCE NO. 93-09-053

REQUIRING ALL SHIPPERS OF AQUA-MARINE PRODUCE TO SECURE INSPECTION PERMIT FROM THE FISH EXAMINER, DEPARTMENT OF AGRICULTURE, BEFORE SHIPMENT IS MADE AND FIXING THE INSPECTION FEE THEREFOR

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. All shippers of aqua-marine produce are hereby required to secure inspection permit from the Fish Examiner, Department of Agriculture, before shipment can be made from this Municipality;

SECTION 2. No Permit to Transport shall be issued to any shipper of aqua-marine produce unless, Inspection Permit from the Fish Examiner, Department of Agriculture, showing that the examined produce are negative of being caught from illegal means is presented;

SECTION 3. There shall be collected by the Municipal Treasurer or his duly authorized representative the following inspection fees:

- a. For medium-size styrofoam box (containing a maximum of 40 kilos) ₱2.00 each
- b. For big-size styrofoam box 3.00

SECTION 4. Any violation of this ordinance shall be punished, upon conviction, by a fine of Two Thousand and Five Hundred Pesos (₱2,500.00) or imprisonment of six (6) months or both such fine and imprisonment at the discretion of the Court, provided however that conviction of any person for any offense under this Ordinance shall not bar his prosecution for any other offense, particularly that of against Presidential Decree 704 which consolidates all fishery laws, rules and regulations of the country, which may have been committed by such person concurrently with the commission of the offense of which he was convicted or in doing a series of acts which constituted the offense of which he was convicted;






