ORDINANCE NO. 93-04-040

AN ORDINANCE OFFICIALLY DESIGNATING SALAS STREET, ATIENZA STREET
AND TEMPLANZA STREET, ONE WAY FOR ALL TYPES OF VEHICLES EN-
TERING BARANGAY POBLACION, THIS MUNICIPALITY

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Ori-
ental Mindoro;

T H A T :

SECTION 1. Salas St., Atienza St. and Templanza St. are
hereby declared one-way for all types of vehicles entering Baran-
gay Poblacion, Bulalacao, Oriental Mindoro;

SECTION 2. All vehicles entering Poblacion must take Salas
St. as an entrance;

SECTION 3. Any person found violating any provision of this
Ordinance shall be punished by a fine of One Hundred Pesos
(P100.00) or an imprisonment of seven (7) days, provided that
subsequent violations thereafter shall be punished by a fine of
Five Hundred Pesos (P500.00) or an imprisonment of Thirty (30)
days or both such fine and imprisonment at the discretion of the
Court;

SECTION 4. All Ordinances inconsistent hereof are hereby re-
pealed, modified accordingly;

SECTION 5. This Ordinance shall take effect ten (10) days
after its posting;

lalacao, Oriental Mindoro.
