"WHEREAS, the Municipal Agricultural Officer is willing and ready to accomodate and share his office to Mr. Boado if only to give credence to the necessity of this request;


NOW, THEREFORE, considering the needs for proper coordination for efficient management and protection to sustained the various environmental program;





Boado, DENR Field Officer to hold office in the Municipality of Bulalacao, Oriental Mindoro.


