"RESOLUTION NO. 95-10-065

AUTHORIZING THE MUNICIPAL TREASURER TO RELEASE THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00) TAKEN FROM THE OTHER SERVICES OF THE OFFICE OF THE MUNICIPAL MAYOR AS PAYMENT FOR LEGAL SERVICES OF ATTY. EDGARDO C. ACERON, LEGAL COUNSEL FOR THE MUNICIPAL GOVERNMENT OF BULALACAO, ORIENTAL MINDORO IN CIVIL CASE NO. 255 ENTITLED RODOLFO V. DAYANGHIRANG, ET AL VERSUS THE MUNICIPAL GOVERNMENT OF BULALACAO, ORIENTAL MINDORO AND OTHER RELATED CASES

"WHEREAS, the Municipal Government, on May 18, 1995, was sued by Rodolfo V. Dayanghirang and Nenita Yang for Forcible Entry and Damages with Temporary Restraining Order and/or Preliminary Mandatory Injunction under Civil Case No. 255;

"WHEREAS, the Municipal Government through its Municipal Mayor, during that time, Ludovico C. Silang, requested the Office of the Provincial Prosecutor for a competent lawyer to represent this Municipality in the abovenoted case;

"WHEREAS, as an answer to the said request, the Provincial Prosecutor certified the inavailability of a Government lawyer to represent this Municipality thereby affirming and allowing the latter to engage the legal services of a competent private counsel;


"WHEREAS, by virtue of the Sangguniang Bayan's Resolution Numbered 95-05-026, the legal services of Atty. Edgardo C. Aceron was engaged with the agreement to pay him the amount of Thirty Thousand Pesos (P 30,000.00), Now, therefore, be it;

RESOLVED, AS IT IS HEREBY RESOLVED, To authorize the Municipal Treasurer to release the amount of Thirty Thousand Pesos (P30,000.00), taken from the other services of the Office of the Municipal Mayor as payment for legal counsel for the Municipal Government of Bulalacao, Oriental Mindoro in Civil Case No. 255 entitled Rodolfo V. Danyanghirang, et al versus the Municipal Government of Bulalacao, Oriental Mindoro and other related cases;


