EARNESTLY REQUESTING THE HONORABLE JESUS B. GARCIA, JR. SECRETARY, DEPARTMENT OF TRANSPORTATION AND COMMUNICATIONS TO ALLOCATE FUNDS FOR THE CONSTRUCTION/INSTALLATION OF A LIGHTHOUSE AT MAASIN POINT, MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, the Municipality of Bulalacao, Oriental Mindoro is a coastal town whereby many sea vessels are regularly traversing on its municipal waters and the navigational routes;

"WHEREAS, Bulalacao Bay serves as mooring place for sea vessels such as overseas, passenger and large fishing boats whenever there is a warning for inclement weather such as typhoons;

"WHEREAS, the installation of a lighthouse in a strategic area such as that of a Maasin point would mean safety among the mariners not to mention the advantage of being properly guided during the course of their voyage thereby preventing getting lost during the onslaught of typhoons where zero visibility should be evident;

"WHEREAS, for and in consideration of the above premises and with the further realization that navigational safety is at the top of the priorities of the national government in an answer to prevent the incidence of sea disasters like the series of sea accidents suffered by the country in the more recent history; Now therefore, be it;




the construction/installation of a lighthouse at Maasin point, Municipality of Bulalacao, Oriental Mindoro;
