EARNESTLY REQUESTING THE HONORABLE GLORIA MACAPAGAL ARROYO, VICE PRESIDENT, REPUBLIC OF THE PHILIPPINES TO ALLOCATE FUNDS FOR THE CONSTRUCTION OF A DORMITORY FOR THE STUDENTS OF THE BULALACAO NATIONAL HIGH SCHOOL IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, the Municipality of Bulalacao, Province of Oriental Mindoro is composed of fifteen (15) barangays separated by sea waters and high mountain ranges making it difficult to reach due to the absence of a functional communication and transportation systems;

"WHEREAS, it is observed that students coming from different barangays of the Bulalacao National High School, the only secondary school in the whole municipality find difficulties in looking for a house for their temporary use during school days since they could not go home everyday due to long distance;


"WHEREAS, the provision of a dormitory inside the campus of the Bulalacao National High School would lessen the burden of both the parents and students alike who still have various activities to attend to;


"WHEREAS, being the Pro-Poor Municipality with limited funds, the abovementioned project could only be realized through the assistance of the benevolent vice president; Now, therefore, be it


