RESOLUTION NO. 11-09-111

RESOLUTION EXPRESSING THE WILLINGNESS OF THE LOCAL GOVERNMENT UNIT OF BULALACAO, ORIENTAL MINDORO TO BE AN ADOPTED MUNICIPALITY OF THE MAKATI CITY GOVERNMENT, MAKATI CITY, METRO MANILA

"WHEREAS, the local Government Code of 1991 grants the Local Government Units the powers to cooperate with one another, whereby Section 33 thereof provides that "Section 33. COOPERATIVE UNDERSTANDING AMONG LOCAL GOVERNMENT UNITS. Local government units may, through appropriate ordinance group themselves, consolidate or coordinate their efforts, service and resources for purposes commonly beneficial to them x x x";

"WHEREAS, the Municipality of Bulalacao, Province of Oriental Mindoro has a largest deposit of high-grade coal and has big potential for tourism development, it having many islets (similar to that of the neighboring world-famous Boracay Island) and other areas declared as tourist-spot reserves under Presidential Decree No. 1801, that needs to be developed with the assistance of other local government unit such as that of the Makati City Government;

"WHEREAS, Makati City is regarded as one of the wealthies and fastest growing cities in the Philippines that being her adopted Municipality shall definitely redound to the socio-economic benefits of the inhabitants herein;

"WHEREAS, the Sangguniang Bayan of Bulalacao, Oriental Mindoro in its desire of being adopted by the Makati City Government passed Resolution No. 09-066-A, series of 2009 to the former Mayor of Makati, the Honorable Jejomar Binay, Sr. expressing its desire to be adopted by Makati City in order to foster camaraderie, coordination and support; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Express the willingness of the Local Government Unit of Bulalacao, Oriental Mindoro to be an adopted Municipality of the Makati City Government, Makati City, Metro Manila;




