RESOLUTION COMMENDING SENATOR JUAN MIGUEL ZUBIRI FOR HIS PRUDENCE AND SENSE OF DELICADEZA IN RESIGNING FROM HIS POST IN THE NAME OF HONOR AND INTEGRITY

“WHEREAS, Senator Juan Miguel Zubiri announced his resignation from the Senate on the wake of alleged machinations, fraudulence, trickery and cheating in the 2007 polls that gave him the 12th slot over his nearest rival, Atty. Aquilino Pimentel III;

“WHEREAS, in his speech he mentioned that the accusations were unfounded and a trial by publicity and systematically divided our nation and has casted doubts in our electoral system, affected not only himself, the Senate but the public as well;

“WHEREAS, he added that the issues being compounded resulted to anguish and misery of his family whose name is tantamount to honor, integrity and decency;

“WHEREAS, it seems that the term personal interest does not exist in Senator Zubiri’s vocabulary, that instead of dinging to power or “kapit-tuko” he prudently opted to leave his post in a statesmanly manner with his honor and of his family intact; the first in the history of our nation;

“WHEREAS, such act of statesmanship and gentility of Sen. Zubiri only proves that there are still people in the government who still believe in delicadeza, people who can rise above their own interests in favor of the common weal and national pride; Now, therefore, be it
