
"WHEREAS, recognizing its importance, Barongbong Bridge needs to be rehabilitated immediately, if possible before the harvest season;


"WHEREAS, the Municipal Government is financially constrained to undertake such repair and rehabilitation of the mentioned bridge; Now, therefore, be it
