" RESOLUTION NO. 97-09-129

REQUESTING THE PROVINCIAL COMMAND, PHILIPPINE COAST GUARD, CALAPAN, ORIENTAL MINDORO TO CONDUCT INVESTIGATION AND APPLY THE NECESSARY ACTIONS TO PREVENT THE INCLUSION OF COMMERCIAL FISHING VESSELS IN THE MUNICIPAL WATERS OF BULALACAO, ORIENTAL MINDORO

"WHEREAS, social equity and justice must prevail to achieve the desired growth and progress at the local level;

"WHEREAS, Section 131 of the RA 7160 defines municipal waters as waters to include "not only streams, lakes and tidal waters within the Municipality, . . . but also marine waters included between two lines drawn perpendicularly to the general coastline from points where the boundary lines of the municipality touch the sea at low tide and the third line parallel (to) the general coastline and fifteen (15) kilometers from them . . .";

"WHEREAS, Section 149 Number (b) 3 of the same Act accords the Municipalities the authority to issue "licenses for the operation of fishing vessels of three (3) gross tons or less for which purpose the Sangguniang Bayan shall promulgate rules and regulations regarding the issuances of such licenses to qualified applicants under existing laws;


"WHEREAS, the continued operation of the big commercial fishing vessels in the municipal waters of this town has resulted to the marginalization of our ordinary fisherfolks, as they are not at par to compete with the operators of these

vessels in terms of capability and capital;

"WHEREAS, our present laws of the land prohibit the operation of such big fishing vessels within the 15 kilometers distance from the shoreline of our Municipality; however most of the local government units are incapable of stopping their operation, hence, the need to request the military arm of the government; Now, therefore, be it


RESOLVED AS IT IS HEREBY RESOLVED, To: Request the Provincial Command, Philippine Coast Guard, Calapan, Oriental Mindoro to conduct investigation and apply the necessary actions to prevent the inclusion of commercial fishing vessels in the Municipal Waters of Bulalacao, Oriental Mindoro.






