RESOLUTION GRANTING THE EXPANDED COVERAGE OF PERSONNEL ECONOMIC RELIEF ALLOWANCE (PERA) TO THE QUALIFIED OFFICIALS AND EMPLOYEES OF THE MUNICIPAL GOVERNMENT OF BULALACAO, ORIENTAL MINDORO

"WHEREAS, DBM Budget Circular No. 12 dated April 7, 1997 was issued in order to prescribe and update rules and regulations on the grant of Personnel Economic Relief Allowance (PERA) as authorized under Section 47 of Republic Act 8250; otherwise known as General Appropriation Act for FY 1997;

"WHEREAS, the said Budget Circular extended the coverage of PERA to all appointive officials and employees of the municipal government; and Section 4.7 of the same prescribed circular schedule for the granting of allowance based in the local government units and it allows the LGUs under Section 4.8 to pay higher than the rates authorized in the schedule for the particular income class at the rate authorized to be applied uniformly to all Personnel entitled to such benefits; Now, therefore, be it


