REQUESTING THE DISTRICT ENGINEER, DEPARTMENT OF PUBLIC WORKS AND HIGHWAY (DPWH), CALAPAN, ORIENTAL MINDORO TO EXPEDITE THE IMPLEMENTATION OF CABURAYAN BRIDGE SITUATED AT BARANGAY POBLACION, BULALACAO, ORIENTAL MINDORO

"WHEREAS, provision of proper transportation system is one of the basic services that the government must deliver to its constituents giving meaning to the ideals of proper public service;

"WHEREAS, due to the constant requests by the residents of Tabok, Barangay Poblacion, Congressman Punzalan allocated portion from CDF to finance the construction of a bridge linking it to Poblacion Proper to serve the residents and protect them from any harm during the occurrences of inclement weather;

"WHEREAS, such project has been delegated to the responsibility of the DPWH and funds were already allocated by the DRM; however construction of the same was not timely done for reasons unknown to this local government unit; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Request the District Engineer, DPWH, Calapan, Oriental Mindoro to expedite the implementation of Caburayan Bridge situated at Barangay Poblacion, Bulalacao, Oriental Mindoro;
