"WHEREAS, as a working arm, the DENR is distributing seedlings in order to save the little that which is left in our environment;


"WHEREAS, it is learned that such Department through PENRO is now distributing seedlings to be planted this rainy season;


"WHEREAS, the Municipality of Bulalacao needs such kind of material support in maintaining the ecological balance of the town of Bulalacao; Now, therefore, be it


