" RESOLUTION NO. 99-03-056

APPROVING THE BARANGAY FUND ANNUAL BUDGET FOR FY 1999 OF BARANGAY MILAGROSA, BULALACAO, ORIENTAL MINDORO APPROPRIATING THE AMOUNT OF FOUR HUNDRED NINETY EIGHT THOUSAND TWENTY PESOS AND FIFTY CENTAVOS (P498,020.50) PASSED UNDER SANGGUNIANG BARANGAY APPROPRIATION ORDINANCE NO. 1, DATED MARCH 7, 1999

"WHEREAS, Section 57 and Section 447 par (11) empower the Sangguniang Bayan to review all ordinances passed by the Sangguniang Barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and not to be inconsistent with law or municipal ordinance;

"WHEREAS, the Sangguniang Barangay of Milagrosa, Bulalacao, Oriental Mindoro submitted its Barangay Fund Annual Budget for FY 1999 showing therein the sources of income and barangay expenditures starting from January 1, 1999 up to December 31, 1999;

"WHEREAS, the Barangay Fund Annual Budget for FY 1999 of Barangay Milagrosa was duly taken up by the Sangguniang Bayan of Bulalacao, Oriental Mindoro in the regular session held on March 15, 1999 and was found to be consistent and in accordance with the priority development projects of the barangay with the advice that all projects funded under the 20% Development Fund be implemented and should not be realigned to any other projects;

"WHEREAS, it is therefore understood that disbursements of appropriations shall be guided by existing COA rules and regulations; Now, therefore, be it
