APPROVING THE BARANGAY FUND ANNUAL BUDGET FOR FY 1997  
OF BARANGAY SAN ISIDRO, BULALACAO, ORIENTAL MINDORO  
APPROPRIATING THE AMOUNT OF TWO HUNDRED SIXTY ONE  
THOUSAND ONE HUNDRED FIFTY SIX PESOS AND SEVENTEEN CEN-  
TAVOS (P261,156.17) PASSED UNDER SANGGUNIANG BARANGAY  
APPROPRIATION ORDINANCE NO. 01, DATED FEBRUARY 2, 1997

"WHEREAS, Section 57 and Section 447 par (1i) empo-

of income and the barangay expenditures starting January  
1, 1997 up to December 31, 1997;

"WHEREAS, the Barangay Fund Annual Budget for FY  
1997 of Barangay San Isidro was duly taken up by the  
Sangguniang Bayan of Bulalacao, Oriental Mindoro in the  
regular session held on March 24, 1997 with the follo-  
wing recommendations:

1. The programs and projects under the  
20% Development Fund should be in  
accordance with Memorandum Circular


No. 96-263 entitled "Policies and Guidelines on the Utilization of the Twenty Percent (20%) Development Fund and Related Matters;


- ii. That the 20% of the 20; Development Fund should be utilized to finance programs that address to Human and Ecological Security (HES);
