EARNESTLY REQUESTING THE HONORABLE ANDREW GONZALES, SECRETARY, DEPARTMENT OF EDUCATION, CULTURE AND SPORTS TO ALLOCATE FUNDS FOR THE CONSTRUCTION OF THREE (3) ROOM SCHOOL BUILDINGS AT BARANGAYS NASUCOB, SITIO LAMBOK, BARANGAY MAUJAO AND CAMBUNANG AND REPAIR AND REHABILITATION OF SEVERAL SCHOOL BUILDINGS ALL AT THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, Section 17, Article II of the 1986 Constitution provides that the State shall give priority to education, science and technology, arts, culture and sports to foster patriotism and nationalism, accelerate social progress and promote total human liberation and development;

"WHEREAS, it is observed that several elementary school buildings of Barangays Nasucob, Sitio Lambok, Barangay Maujao and Cambunang all at the Municipality of Bulalacao are badly ruined and dilapidated which pose danger to the lives and properties of the pupils especially during the onslaught of the bad weather condition;

"WHEREAS, aside from the repair and rehabilitation of the school buildings mentioned above, there is also a need to construct additional school buildings in order to accommodate the increasing enrollees every year;

"WHEREAS, it is believed that quality education ensures all possible conditions for the fullest development of the pupils given the right opportunities and enough facilities to achieve educational goals; Now, therefore, be it


