CAFE, PROVINCIAL IRRIGATION OFFICER, NATIONAL IRRIGATION ADMINISTRATION, CALAPAN, ORIENTAL MINDORO TO PRIORITIZE THE REHABILITATION OF THE COMMUNAL IRRIGATION SYSTEMS AT BARANGAYS NASUCOB, CAMBUNANG AND MAUJAO ALL OF THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO AND ALLOCATING FUNDS THEREFOR

"WHEREAS, the Barangays of Nasucob, Cambunang and Maujao, this Municipality are vast agricultural lands whose major source of income of the residents is farming;

"WHEREAS, it is sad to note that only 8% of the total area mentioned above can be utilized in the production which resulted to a big deficit in terms of its total annual production and consumption;


"WHEREAS, one of the factors that aggregate the problem, aside from the inadequacy of technical knowledge on the part of the farmers and high cost of production, is the absence of infrastructural support facilities, particularly that of a functional irrigation system;


