EARNESTLY REQUESTING THE REGIONAL DIRECTOR, DEPARTMENT OF BUDGET AND MANAGEMENT, REGION IV, MANILA TO PLEASE IMMEDIATELY RELEASE THE FIVE PERCENT REDUCTION IN THE INTERNAL REVENUE ALLOTMENT (IRA) WITHHELD FOR 1998 FOR THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO

"WHEREAS, Administrative Order No. 372 dated 27 December 1998 entitled "Adoption of Economy Measures for FY 1998", issued to address the economic difficulties brought about by the peso devaluation in 1997, whereby Section 4 thereof provided that the amount equivalent to 10% of the Internal Revenue Allotment (IRA) to local government units shall be withheld;

"WHEREAS, Administrative Order No. 43 dated 10 December, 1998 issued by President Joseph Ejercito Estrada ordered the release of the five percent (5%) of such withheld IRA to the local government units;


"WHEREAS, the Municipality of Bulalacao, Province of Oriental Mindoro is in dire need of getting additional funds to augment its monetary capacity in the performance of its corporate duties; Now, therefore, be it


